



GVR Club Sub-Account Application Form and Process

ADOPTED BY GVRFB BOARD ON NOVEMBER 29, 2017 BY "UNANIMOUS CONSENT"

GVR Clubs may wish to make donations for charitable projects and to receive a tax deduction that comes along with the donation from the GVR Foundation, a 501(c)(3) organization. GVRFB has initiated a GVR Club Sub-accounts Pilot Program to assist in this effort. The process begins with an application from a GVR Club wishing to engage in this pilot program.

Upon receipt of a GVR Club application, GVR Foundation will evaluate and determine whether or not to include the GVR Club in the sub-accounts pilot program. The GVR Club applicant may be asked to make a presentation to the GVRFB Board of Directors. If approved to participate in the sub-accounts pilot program, the GVR Club may receive donations and grant funding for specific GVR and community projects consistent with GVR's mission.

After GVRFB determines the GVR Club eligibility to establish a GVRFB sub-account, GVRFB will oversee and administer the sub-account. Funds deposited into sub-accounts are for specific community and/or GVR projects only. GVR Club member dues are not eligible as financial contributions to sub-accounts.
